Kalgoorlie Warden's Court Procedure

1. Practice Direction 1 of 2021 to be followed for proceedings before the Kalgoorlie and Leonora Warden.
2. All Warden's court email correspondence and minute of consent orders to be emailed to:

3. Parties are required to ensure the Notice of Representation/Cessation of Representation/Change of Representation to be filed at least 7 days before the scheduled mention hearing to allow for the processing of the filing and service on the other party.
4. Parties that are appearing, are requested to advise the Warden's Tenure Officer of their manner of appearance by 12:00pm the day before the mention hearing by email to mineraltitles.kalgoorlie@dmirs.wa.gov.au
5. The Court *prefers* in person appearances (inc. via video link from Mineral House) and that audio appearances to be used in extenuating circumstances (outside the Perth Metropolitan/City of Kalgoorlie-Boulder area) or where the Warden has directed an audio appearance.
6. Where an Audio link appearance is granted it must be by a **DIRECT** line.
