



## List of recognised shotfirer training course providers

(as at June 2022)

The following table lists training course providers currently accredited to deliver national units of competency for blasting (RIIBLA) recognised by DMIRS.

Prospective shotfirer trainees should obtain training from these organisations. Generally no other training will be accepted by DMIRS as competency evidence for shotfirer licence applications.

Other RTOs may be scoped to provide shotfirer training, but you should contact DMIRS beforehand to confirm if the training will be accepted.

4	For all underground coal operations	RIIBLA205E – Store, handle and transport explosives RIIBLA302E – Conduct shotfiring operations in underground coal mines RIIBLA305E – Conduct secondary blasting

A shotfirer training certificate of competency is evidence that a person has completed the training specified in the relevant Unit of Competency and has been assessed against the National Assessment Instrument. Possession of a shotfirer's licence is not to be taken by employers to mean that the person has all the experience and skills required for specific workplace tasks.
