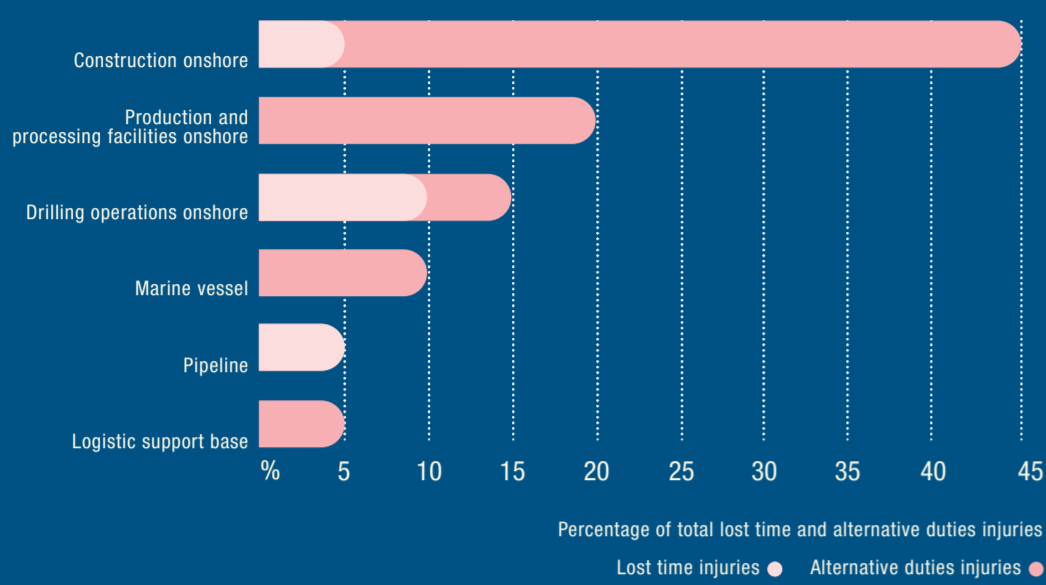

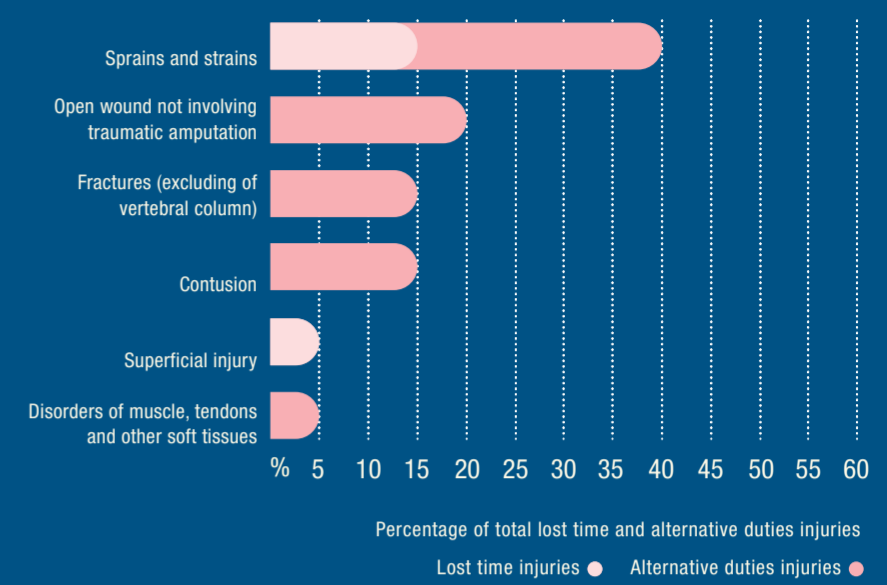
LOST TIME AND ALTERNATIVE DUTIES INJURIES: TYPE OF FACILITY



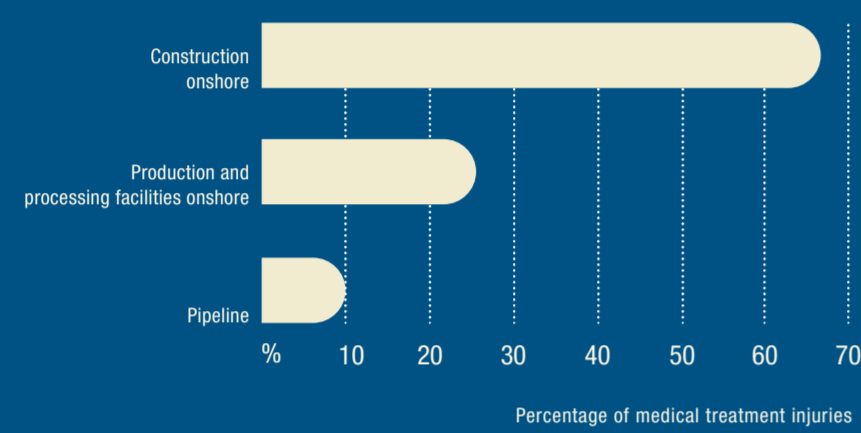
LOST TIME AND ALTERNATIVE DUTIES INJURIES: BREAKDOWN AGENCY



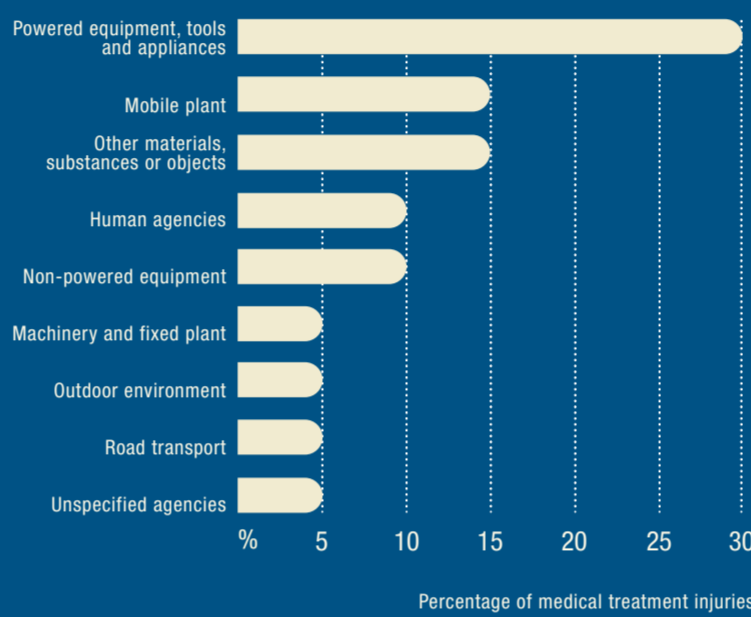

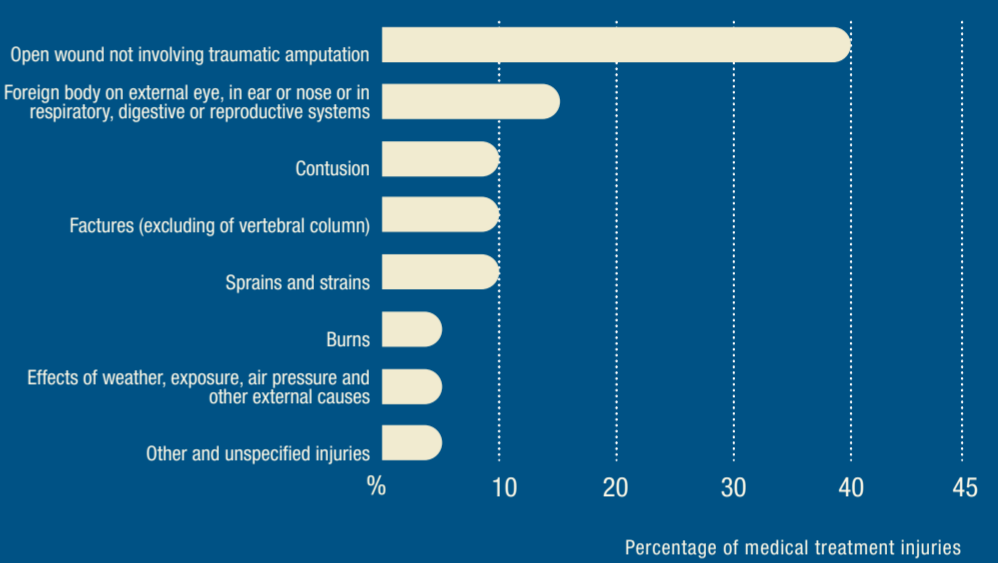

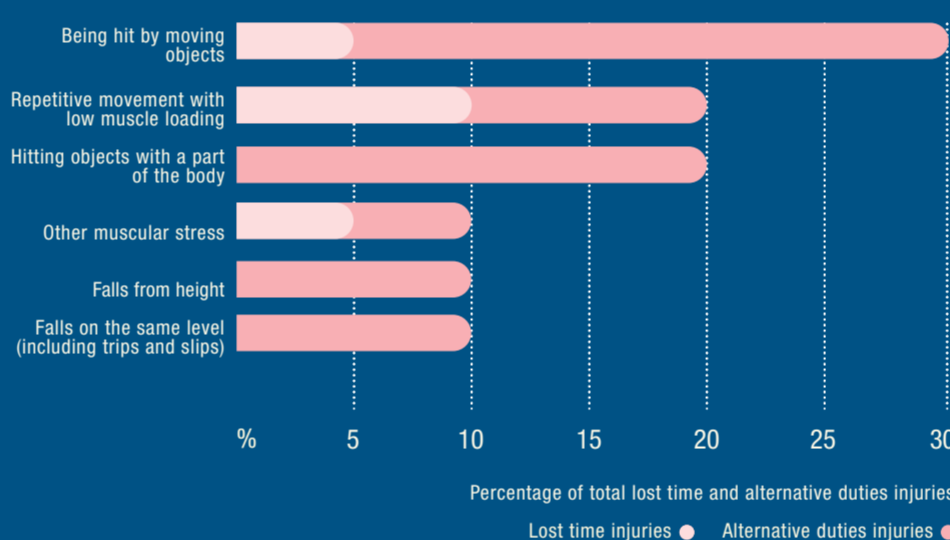

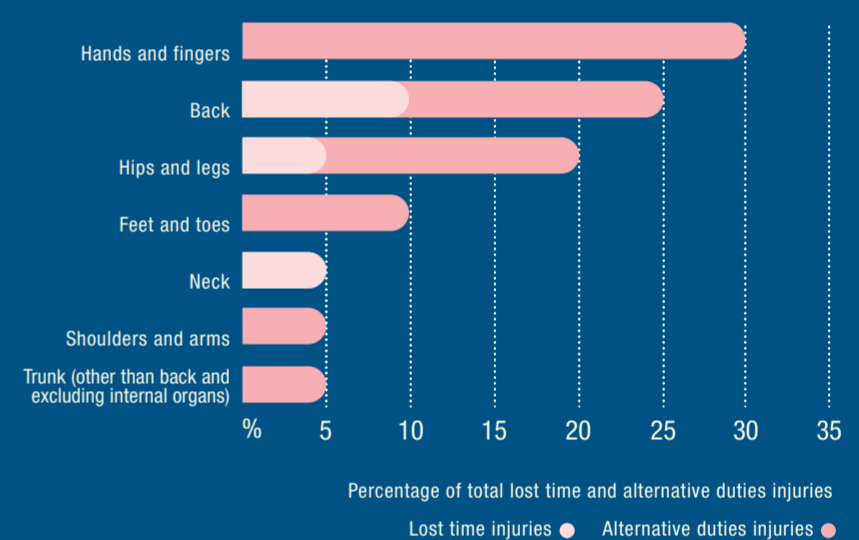
MEDICAL TREATMENT INJURIES: NATURE OF INJURY



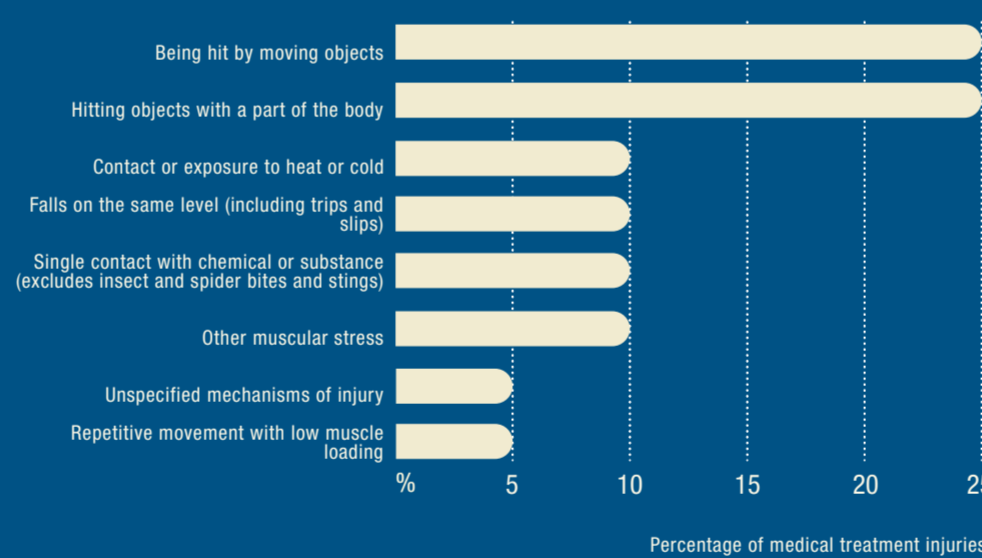
LOST TIME AND ALTERNATIVE DUTIES INJURIES: MECHANISM OF INJURY



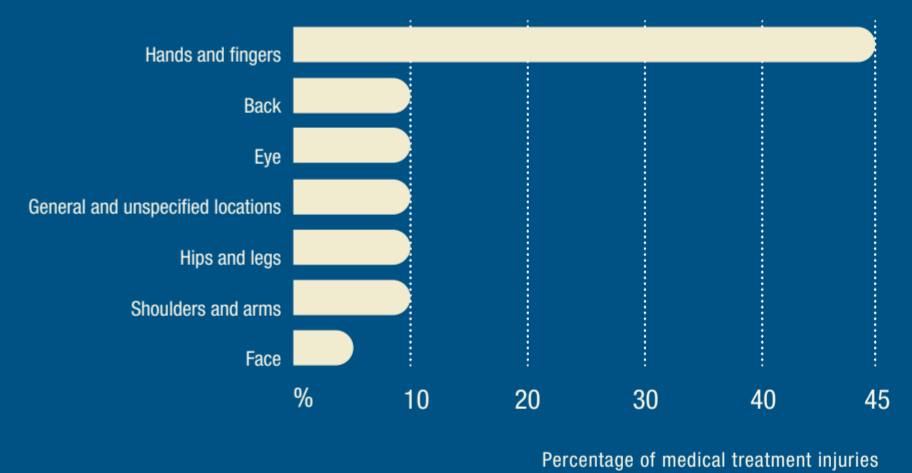
LOST TIME AND ALTERNATIVE DUTIES INJURIES: PART OF BODY

Statistical summary

- No fatal accidents reported during 2009-10
- 4 LTIs reported during 2009-10, 1 less than the previous year
- 15 ADIs reported during 2009-10, 3 more than the previous year
- 19 MTIs reported during 2009-10, 10 more than the previous year
- Overall LTI frequency rate improved by 47% during 2009-10, falling from 1.9 to 1.0
- Overall ADI frequency rate improved by 16% during 2009-10, falling from 4.5 to 3.8
- Overall MTI frequency rate deteriorated by 44% during 2009-10, rising from 3.4 to 4.9
- A total of 3.91 million hours were worked during 2009-10 consisting of 1.08 million hours worked by employees and 2.83 million hours worked by contractors, an increase of 32% over the previous year
- An additional 0.01 million hours were reported as being worked by marine crews during 2009-10, 0.01 million hours less than the previous year

Definitions

LOST TIME INJURY (LTI)

A lost time injury (LTI) is a work injury that results in an absence from work for at least one full day or shift any time after the day or shift on which the injury occurred.

ALTERNATIVE DUTIES INJURY (ADI)

An alternative duties injury is a work injury which is not an LTI that results in the injured person being unable to fully perform his or her ordinary occupation (regular job) any time after the day or shift on which the injury occurred, and where either alternative or light duties are performed.

MEDICAL TREATMENT INJURY (MTI)

A medical treatment injury (MTI) is a work injury which requires treatment beyond normal first aid but which is not a lost time injury or an alternative duties injury.

FREQUENCY RATE (FR)

The number of injuries per million hours worked.

LOST TIME INJURY FREQUENCY RATE (LTIFR)

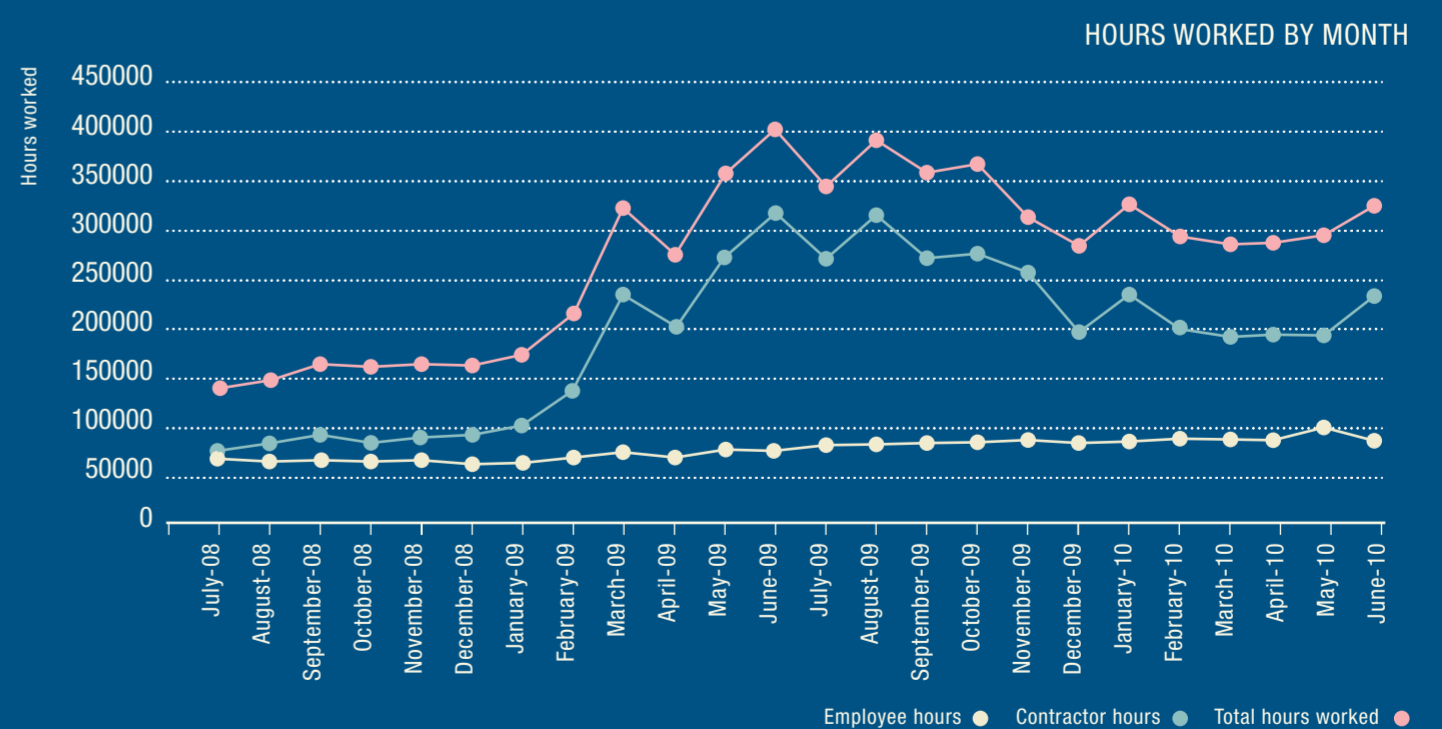
The number of lost time injuries per million hours worked.

ALTERNATIVE DUTIES INJURY FREQUENCY RATE (ADIFR)

The number of alternative duties injuries per million hours worked.

MEDICAL TREATMENT INJURY FREQUENCY RATE (MTIFR)

The number of medical treatment injuries per million hours worked.
