Approvals Performance Report September Quarter 2017

Highlights

During the September quarter 2017, the department received 509 mineral Exploration Licence, 349 Prospecting Licence and 70 Mining Lease applications. Ninety-eight per cent of Exploration and Prospecting Licence applications were finalised within 65 business days. Fifty-eight per cent of Mining Lease applications were finalised within 65 business days. This is below the DMIRS approval performance target of finalising more than 80 per cent of applications within the target timeline. Changes to government policy and internal administrative actions relating to the end of the Mine Rehabilitation Fund reporting period affected the department's Mining Lease approval performance.

The number of mineral exploration Programme of Work applications received during the September quarter remained steady at 658. The number of Programme of Work applications received during each quarter was:

One-hundred-and-twenty-two petroleum tenure and activity applications were received during the reporting period. Ninety-two per cent of applications were finalised within target timelines.

Trends

The number of mineral exploration Programme of Work applications has increased since the second half of 2016 and remained steady during the first nine months of 2017.

Figure one: Number of mineral exploration Programme of Work applications received during the period 1 July 2016 – 30 September 2017.


