DMIRS Approvals Reporting – WA Resource Sector Applications

March Quarter 2019 (1Q 2019)

DMIRS is changing the way approval reporting is presented. Commencing this quarter, the department will use dashboard graphics and spatial mapping to report agency approval performance and application trend information.

New spatial heat maps will show the location and density of selected mining and petroleum applications across the State during the report period.





Figure 1: Mineral exploration licence applications granted (1Q 2019)

Figure 1 opposite shows the location and density of mineral exploration tenements granted in Western Australia during the period. Figure 2 provides a breakdown of the average number of business days taken to grant exploration licences by DMIRS, the proponent and other agencies.

In this quarter, 86 per cent of exploration licence applications were finalised within the DMIRS target of 65 business days.


As shown in Figure 2, DMIRS averaged 47.9 business days to finalise 516 exploration licences. The proponent time of 29.3 business days represents the time proponents took to provide missing or other information required for the application.

The Pending Other Agencies time of 169.5 business days includes the time taken for *Native Title Act 1993* requirements, objections in the Warden's Court and reserve/vested land referral requirements to other agencies.

All exploration licence applications are subject to the expedited process which includes a four month notification period prescribed under S29 of the *Native Title Act 1993*. In this quarter, 20 per cent of exploration licence applications were subject to objections lodged in the Warden's Court and 13 per cent were subject to reserve/vested land referrals to other agencies.








Environmental Protection Act 1986 - Native Vegetation Clearing Permits
