



YAMATJI MARLPA ABORIGINAL CORPORATION (YMAC) REGIONAL STANDARD HERITAGE AGREEMENT (RSHA) CHECKLIST

The State Government has a policy whereby applicants for Exploration Licences and Prospecting Licences are required to sign a Regional Standard Heritage Agreement (RSHA) or prove they have an existing Alternative Heritage Agreement before the applications will be submitted to the Native Title Act 1993 (NTA) Expedited Procedure.

The Yamatji Marlpa Aboriginal Corporation is the representative Aboriginal/Torres Strait Islander body of the Yamatji (Murchison and Gascoyne) and Pilbara regions of Western Australia. As such the YMAC has provided the State government with a checklist to ensure that tenement applicants complete the RSHA properly. YMAC has also advised that the *Nyiyaparli* People and the *Badimia* People, have appointed their own third party heritage providers to act as their agent for the purpose of negotiating and signing heritage agreements, and ensuring heritage protection.

Please make sure you have completed the following before forwarding to YMAC or the relevant agents listed below:
